CHAMPIONSHIP PERTINENT INFORMATION

ELIGIBILITY: Entries are open to female amateur golfers who have reached their 50th birthday by April 24, 2012 and have a maximum handicap index of 30. Both partners, including foreign contestants, must meet all eligibility requirements. Entries are subject to rejection at anytime.

Online entries will be accepted thru our website: www.womenstrans.com. Online processing requires a credit card; PayPal is our official credit card processor.

Entry forms may be printed from the TRANS website and postal mail addressed to the Entry Director along with a check or money order made payable to WTNGA. Email addresses are requested. An email or postal mail will be sent acknowledging the receipt of ALL entry applications.

Entries may be submitted individually or as a team. If submitted individually, each player MUST list her partner's name and team acceptance will be determined when both individual applications have been received and matched up by the Entry Director.

Entries will be accepted as they arrive at the Entry Director's email or postal address until January 22. Following that date, the balance of the 56-team field will be made up of the lowest combined handicap indices of those submitting entry applications. Notice of acceptance to all teams will be made on or before 5:00 P.M. EDT, March 18, 2012. If there is a tie in the combined handicap index for the 56th team, the earliest date of entry will determine the team to be accepted. Entries not accepted will be placed on standby in the order of total combined handicap indices and vacancies will be filled in that order. Late entries will be accepted and either added to the standby list or entered in the championship if the field is not full.

A player may substitute a partner at any time prior to April 24, 2012, provided the substituted player meets all eligibility requirements. Accepted entries may receive a refund of fees if cancellations are made prior to April 5, 2012. After this date, refunds will only be made for injury or illness that has been certified by a doctor's written report and which has been approved for refund by the Board. A \$25 service charge will be deducted from each player's refund.

CHAMPIONSHIP FORMAT: Format will be 54-hole four-ball stroke play (Rule 31) in which two competitors play as partners, each playing her own ball. The lower score of the partners is the score for the hole. Each day will consist of an 18 hole round. All teams will qualify for flights based on their 36 hole total score. The committee will determine the number of teams per flight after qualifying rounds.

PRACTICE ROUNDS: A practice round may be scheduled on Sunday, April 22 or Monday, April 23 by calling the JW Marriott Poro Shop, 760.341.1756 thirty days in advance (March 22 through April 21). Please identify yourself as a TRANS contestant.

PUBLICITY, PROMOTION and BROADCASTING: The TRANS may arrange for promotion of this Championship for radio, television, broadcasting and other exhibition and publication of this Championship, including the TRANS Website. By this application, the player consents to the use by the TRANS, or persons authorized by the TRANS of her name, likeness, voice and references to her and photographs and other images of her and her play connected with her appearance in this Championship or any portion(s) thereof, in connection with such media promotion, broadcasting and other exhibition and publication of this Championship.

PRIZES AND AWARDS: The low gross team will be presented THE WILMA CUP perpetual trophy to remain in their possession for one year. The CUP is actually two beautiful antique silver vases donated in honor of Wilma Gilliland in recognition of her many years of dedicated support and commitment to WTNGA.

The low gross team after 36 holes qualifying will receive the LUCILE ROBINSON MANN perpetual award donated by the TRANS 1941 Champion, Lucile Mann. This lovely sterling silver tray was presented to Mrs. Mann by the Women's TRANS National Golf Association in honor of her victory.

First, second and third low gross teams in each flight will receive a prize.
